Edition 3 had conflict between the definition of content rules and the examples given in Annex I.4. DR 255/Cor 2 changes the content rule specification to be in accordance with the examples in Annex I.4. Unfortunately, this introduced an ASN.1 error as indicated by the following error message from the ASN.1 checker:

The 'UNIQUE' keyword shall not be present since the field '&structuralClass' is not a fixed-type value field.
